## Part One - Introduction

#### 1.1 The Competition

- 1.1.1 The Competition invites interested Full Members of HKIA to contribute design ideas for the construction of the architectural installations for the 2025 National Games in Hong Kong.
- 1.1.2 The 2025 National Games in Hong Kong is comprised of the 15<sup>th</sup> National Games (NG), the 12<sup>th</sup> National Games for Persons with Disabilities (NGD) and the 9<sup>th</sup> National Special Olympic Games (NSOG), collectively as the "Games".

#### 1.2 The Objectives

- 1.2.1 This Competition is a single-stage design competition, aiming to collect innovative design ideas and concepts for the construction of Architectural Installation.
- 1.2.2 The design should achieve the following objectives:
  - (i) Collaboration & Unity

To exhibit the spirit of collaboration and unity, as this is the first time that the Games are co-hosted by Guangdong, Hong Kong and Macao.

#### (ii) Sportsmanship & Health

To foster a culture of sports and physical activities, for the promotion of healthy living, as well as sportsmanship & fairness.

#### (iii) Respect & Inclusiveness

To exhibit the spirit of respect & inclusiveness, as the Games are inclusive for both the able & the disabled.

- (iv) To create societal values, enhance cohesion, elevate Hong Kong's image and drive economic benefits.
- (v) To promote innovation and creativity.
- (vi) To promote sustainability and circularity.
- (vii) To inspire youth and future generations, the spirits of pursuance of dreams and strive for excellence of the athletes.
- (viii) To inspire and catch the attention of the public, at the end is durable, buildable and cost-effective.

#### 1.3 The Background

1.3.1 The "Architectural Installation Design Competition for the 2025 National Games in Hong Kong" for the National Games Coordination Office (Hong Kong) (NGCO) under the Culture, Sports and Tourism Bureau (CSTB) is to create and enhance public awareness and commemorate the 15th National Games, the 12th National Games for Persons with Disabilities and the 9th National Special Olympic Games, collectively as the "Games", to be co-hosted by Guangdong, Hong Kong and Macao in 2025.

- 1.3.2 Organised by the General Administration of Sport of China once every four years, the National Games of the People's Republic of China (NG) is the country's highest-level and largest national multi-sports event. The 15th NG will be held in Guangdong, Hong Kong and Macao from 9 to 21 November 2025. Elite athletes from different provinces, municipalities and special administrative regions will gather in the three places to vie for top honours in different events.
- 1.3.3 Hong Kong will stage eight competition events for the 15th NG, namely basketball (men U22), track cycling, fencing, golf, handball (men), rugby sevens, triathlon and beach volleyball, as well as one mass participation event, which is bowling. Besides, athletics marathon and road cycling events, which will be organised by Shenzhen and Zhuhai respectively, are being planned to run through Guangdong, Hong Kong and Macao to showcase the integrated development of the three places.
- 1.3.4 The National Games for Persons with Disabilities (NGD) of the People's Republic of China, featuring Paralympic sports, is the nation's highest level multi-sports event for persons with disabilities, while the National Special Olympic Games (NSOG) is conducted to encourage persons with intellectual disability to participate in sports competitions. Both of the Games are normally held every four years.
- 1.3.5 The 12th NGD and the 9th NSOG are co-organised by the China Disabled Persons' Federation and the General Administration of Sport of China and will be held from 8 to 15 December 2025. Same as the 15th National Games, these national events will be conducted in Guangdong, Hong Kong and Macao. The NGD and NSOG will feature sports events in four categories for athletes with physical, intellectual, visual or hearing disability.
- 1.3.6 Hong Kong will stage four competition events: boccia, wheelchair fencing and table tennis (TT11) for the NGD, and table tennis for the NSOG. In addition, Hong Kong will organise one mass participation event of para dance sport.
- 1.3.7 The co-hosting of the Games by Guangdong, Hong Kong and Macao for the first time is of paramount significance. It is in line with the objectives of building a bay area for leisure and a healthy bay area set out in the Outline Development Plan for the Guangdong-Hong Kong-Macao in the GBA. It also helps deepen the exchanges and collaboration between Guangdong, Hong Kong and Macao, and provides a valuable opportunity for the three places to collaborate in sports in the GBA. Hong Kong will work closely with Guangdong and Macao and spare no effort to organise a "simple, safe and wonderful" NG.
- 1.3.8 In order to commemorate these special mega events in Hong Kong, CSTB aspires to enhance the awareness of the events through holding an architectural installation design competition.
- 1.3.9 Two sites have been selected for the winning proposals, namely the site at Central and Western District Promenade (Central Section) and another site at the Kai Tak Station Square.
- 1.3.10 The winning proposals that can best achieve the objectives stated will be selected by the panel of jurors and installed at prominent venues as selected.

## Part Two - The Design Brief

#### 2.1 The Sites

- 2.1.1 2 sites are identified for the competition. Participants have the liberty to submit entries for either one or both of the sites.
- 2.1.2 The 2 sites are:
  - Site A: Central and Western District Promenade (Central Section) Site Area approx. 236 m<sup>2</sup>; for site dimension refers **Annex 2**
  - Site B: Kai Tak Station Square (comprised of 2 locations)

Location B1: Site Area approx. 128 m<sup>2</sup>; for site dimension refers **Annex 2** Location B2: Site Area approx. 100 m<sup>2</sup>; for site dimension refers **Annex 2** 

Submission for Site B MUST include both Locations B1 and B2.

- 2.1.3 For detailed information of the sites, please refer to **Annex 1**.
- 2.1.4 Participants can choose to enter the competition for Site A or Site B, or both sites.

#### 2.2 Mandatory Design Requirements

- 2.2.1 The design shall comply with all the related statutory requirements, i.e. Cap. 123F Building (Planning) Regulations, Code of Practice for Fire Safety in Buildings 2011 (2024 Edition), Fire Services Ordinance (Cap. 95).
- 2.2.2 For the compliance to the related statutory requirements and structural safety, the Professional Team of Authorized Persons, Registered Structural Engineer, Independent Checkers, Registered Contractor with competent experience must be nominated (in Annex 3).

#### 2.3 Other Design Requirements

2.3.1 General Requirements

The design is:

- (i) to exhibit the spirits of the Games
- (ii) to commemorate the Games to be staged in Hong Kong as one of the co-host cities and the meaningful collaboration within GBA
- (iii) to attract the public's attention and engagement
- (iv) to be structurally safe and durable for standing of a minimum of 10 years
- (v) to be of high design quality standard
- (vi) to consider future easy dismantling and relocation (if needed)
- (vii) to consider future sustainability, circularity and durability of materials
- 2.3.2 In addition to the mandatory design requirements set out in clause 2.2 above, the Participants should comply with all other design requirements as set out in **Annex 2**.
- 2.3.3 Creativity, Originality and Relevance to the Objectives

- (i) The design should be a signature icon clearly expressing the spirit of the Games and easily recognizable from the surroundings
- (ii) The design should adopt innovative and creative ideas in architectural and engineering design and construction
- (iii) To address the objectives as described in clause 1.2

#### 2.3.4 Buildability and Durability

- (i) The design is to be constructable within the period between mid of June to mid of October 2025.
- (ii) The design is to comply with the structural, building services, safety and health requirements, as specified in **Annex 2**.
- (iii) The ease of constructing the proposed design is practicable and reasonably completed within the stipulated timeframe.
- (iv) The design is to cater for possible future modification as detailed in **Annex 2**.
- (v) It is desirable that the major structural components of the winning design proposals could be pre-fabricated off-site and assembled on site.
- 2.3.5 Sustainability and Environmentally Friendly Materials

The design should be sustainable, environmentally friendly and contributing to carbon neutrality. The design should aim for circularity upon dismantling in the future.

#### 2.3.6 Cost Effectiveness

The design should be cost effective and within budget. The design fee and construction cost for installations at Sites A and B are as follows:

#### Design Fee:

Site A: HK\$500,000 Site B: HK\$500,000

#### **Construction Cost:**

Site A: to be capped at HK\$4.5 million (inclusive of a cap of professional team fee of HK\$500,000).

Site B: to be capped at HK\$5.5 million (inclusive of a cap of professional team fee of HK\$500,000).

- 2.3.7 For details of other Design Requirements, please refer to **Annex 2**.
- 2.3.8 While the installations are designed to exhibit the objectives set out in clause 1.2.2 of Part One Introduction, entries meeting the following criteria will be preferred:

  Site A: The design with more emphasis on the objective of "Collaboration & Unity" (i.e. to exhibit the spirit of collaboration and unity, as this is the first time that the Games are co-hosted by Guangdong, Hong Kong and Macao in the Greater Bay Area).

Site B: The design with more emphasis on the objective of "Sportsmanship and Healthy Living", i.e. To foster a culture of sports and physical activities, for the promotion of healthy living, as well as sportsmanship & fairness.

The above emphasis does not exclude the other objectives as stated in clause 1.2.2 of Part One – Introduction.

## Part Three – Submission

#### 3.1 Registration

- 3.1.1 Interested parties shall first register for the Competition via the online registration system at the Competition Website at **www.NGDesignCompetition.hkia.net**. The Registration will close on **Date 6** as set out in the Competition Timetable in clause 4.10.1.
- 3.1.2 Any registration received after the stipulated time and date above will be disqualified.
- 3.1.3 Those who have not registered will not be accepted to enter the Competition.
- 3.1.4 A Confidential Registration Number will be assigned and emailed to each Participant within three working days after the registration. Participants who have not received the Confidential Registration Number should contact the Professional Advisor via email <a href="MGDesignCompetition@hkia.net">MGDesignCompetition@hkia.net</a> for clarifications.
- 3.1.5 The Professional Advisor shall have the right to require the Participant to submit or re-submit a duly completed and signed Entry Form and any supporting documentation within the period as specified by the Professional Advisor. The Professional Advisor reserves the right to disqualify the Entry from any Participant who fails to submit or re-submit the documents as required by the Professional Advisor.

#### 3.2 Enquiries by Participants

- 3.2.1 Participants may make enquiries regarding the details of the Competition to the Professional Advisor on or before **Date 5** as set out in the Competition Timetable in clause 4.10.1. The Professional Advisor will, in response, upload his replies to the Competition Website on **Date 7**. The Professional Advisor will not reply directly to any individual Participant.
- 3.2.2 All enquiries shall be submitted in English or Traditional Chinese. Enquiries submitted in other languages will not be responded to.

#### 3.3 Entry Submission

3.3.1 Entries shall be submitted in person and online, and must be received by the Professional Advisor at the following address <u>not earlier than 10 calendar days before **Date 8**, i.e. **9 May 2025**, during opening hours and <u>before 5pm on **Date 8**</u>, i.e. **19 May 2025**.</u>

- 3.3.3 HKIA may have special arrangement for the office hours and Participants are advised to call and check the opening hours at 2511 6323 prior to the submission.
- 3.3.4 Late submissions or those without registration under clause 3.1 will be disqualified. Please refer to clause 3.4 on the mandatory entry submission requirements.
- 3.3.5 If Tropical Cyclone Warning Signal No. 8 or above, or a Black Rainstorm Warning Signal or "extreme conditions after tropical cyclone" announced by the Government is/are in force within three hours before the submission deadline set out above, the submission deadline will be postponed to 2:00 pm the first working day after all Tropical Cyclone Warning Signal No. 8 or above, Black Rainstorm Warning Signal and "extreme conditions after tropical cyclone" announced by the Government has/have ceased to be in force.
- 3.3.6 No responsibility will be accepted by the Government, any member of the Organiser, Organising Committee, and the Professional Advisor for the failure of digital delivery of any Entry or damage to any Entry.
- 3.3.7 Upon submission of Entries, Participants are deemed to have accepted all terms and conditions set out in the Competition Document.

#### 3.4 Mandatory Entry Submission Requirements

Entries shall be submitted in person and online. Details of online submission will be given upon registration.

#### 3.4.1 **Document Submission**

#### 3.4.1.1 <u>Entry Form</u>

One (1) no. of true copy of the duly completed and signed Entry Form (**Annex 3**) by the Participant and, in the case of a Team Participant, by each member of the team, together with the Deed of License and Undertaking (**Annex 4**).

The Entry Form together with the Deed of License and Undertaking, the Deed of Assignment and Undertaking (Annex 3, 4 & 5), and the Proof of Eligibility shall be enclosed in a sealed white opaque A4 envelope clearly marked with "Confidential – Entry Submission for Architectural Installation Design Competition for the 2025 National Games in Hong Kong", then affixed to the A2-sized wrapping envelope as required in clause 3.4.2.2 for submission.

#### 3.4.1.2 Proof of Eligibility


One (1) no. of true copy of the proof of eligibility, i.e. membership card of HKIA, of the Participant or the Team Leader in the case of a Team Participant shall be enclosed in the A4 envelope as required in clause 3.4.1.1.

#### 3.4.1.3 <u>Participant's Deed of Assignment and Undertaking</u>

One (1) no. of true copy of the duly completed and signed Deed of Assignment and Undertaking (**Annex 5**) by the Participant and, in the case of a Team Participant, by each member of the team. It shall be enclosed in the A4 envelope as required in clause 3.4.1.1.

#### 3.4.2 **Design Submission**

3.4.2.1 All drawings are to be prepared in the metric scale and drawn / printed on papers of an A2 international size which shall be 420mm x 594mm. The number of print outs submitted shall be two (2). All print outs shall be arranged in landscape layout format (no backing or mounting required) and numbered at the back for the ease of display setup as shown below:



- 3.4.2.2 All Drawing papers must be marked with Confidential Registration Number, on the top right-hand corner on the back of each drawing. No other identification marks shall be used. The drawing papers shall be enclosed in a sealed opaque **A2-sized wrapping envelope**.
- 3.4.2.3 The Drawing papers shall contain the following drawings:
  - (i) Master layout plan of scale 1:500
  - (ii) Two (2) layout plans of scale 1:50
  - (iii) At least two (2) elevations and two (2) sections of scale 1:100
  - (iv) Detail drawing(s) of scale 1:20 showing major design features and materials
  - (v) Computer renderings, perspectives or axonometric drawings showing the spatial arrangement, architectural features and its relationship to the elements and surroundings
  - (vi) Diagrams or illustrations demonstrating the incorporation of the required equipment as listed in the equipment schedule in **Annex 2**
  - (vii) Other diagrams or illustrations demonstrating the flexibility of use of the architectural installation e.g. day and night, attractiveness to locals and visitors, ability to adapt to different events and occasions, etc.
- 3.4.2.4 Photographs, diagrams, collages and any other means of 2D presentation are permitted to illustrate the concept of the site-specific considerations, general layout of the architectural installation design. Such information, however, must be presented within the A2 sized drawing papers.
- 3.4.2.5 A Design Statement explaining the detailed design ideas and concepts shall be submitted. The design statement shall be in both Traditional Chinese and English in no more than 500 words each, and each printed on one (1) A4 international size paper which shall be 297mm x 210mm. The font type shall be Times New Roman at font size 12. The Confidential Registration Number shall be marked on the top right-hand corner on the rear of this A4 paper. No other identification marks shall be used. The design statement shall be enclosed in the envelope as required in clause 3.4.2.2.

#### 3.4.3 Online Submission

All documents and drawings mentioned in clause 3.4.1, 3.4.2 shall also be submitted online. The Confidential Registration Number shall be marked in the online submission. No other identification marks shall be used. The online submission shall contain:

- (i) A2 Entry drawings in full size (420mm x 594mm) in PDF format of resolution not less than 300 dpi:
- (ii) Design statement in Microsoft Word 97-2003 and PDF formats;
- (iii) 5 key perspectives or images in JPEG format of resolution not less than 300dpi; and
- (iv) Document in clause 3.4.1: Entry Form, Proof of Eligibility, Deed of Assignment & Undertaking.

#### 3.5 General Submission Requirements

#### 3.5.1 Presentation Media

The drawings as described above are the only recognized presentation media. Any Entry with attachment on the drawings may lead to disqualification. No other types of presentation media such as scale model(s), animation(s) or internet web page design will be required or accepted.

#### 3.5.2 Legibility of drawings

All drawings shall be prepared with the boldness and clarity which will permit reduction by photographic means so that they may be used for reference and publication purposes.

#### 3.5.3 Design requirements

Participants are required to observe and respond to the design requirements as set out in this Competition Document.

#### 3.5.4 No Physical Model

No Physical model will be accepted. Entry with submission of deliverables other than the requirements in this Competition Document will be disqualified.

#### 3.6 Duplicate Copy of Entries

- 3.6.1 The Government, Organiser, Organising Committee and the Professional Advisor will not be responsible for any damage or loss of the Entries howsoever caused. Submissions would be disposed of after the Competition and would not be returned to the Participants.
- 3.6.2 Participants are advised to retain a duplicate copy of all their submitted Entries in case of any unforeseen events which may lead to damage or loss of the Entries. Under such circumstances, the Participants will be requested to forward the duplicate copy of their Entries to the Professional Advisor for subsequent arrangement at no additional costs to the Government and the Organiser.

#### 3.7 Anonymity of Entries

- 3.7.1 All Entries must be marked with the assigned Confidential Registration Number and written at the top right-hand corner at the back of each presentation paper and explanatory statement and in the submission of entry. No other identification marks may be used, and if found, the entries will be disqualified.
- 3.7.2 Any presentation, explanatory statement pages and entries **submitted shall have no name or mark** that could serve as a means of identifying the Entry, **except for the Confidential Registration Number**. The Professional Advisor, upon receiving the Entries, shall remove and destroy any wrapping materials with markings that may reveal any identification of the Entry. All Entries shall maintain anonymity during the whole assessment process. Before the announcement of the results of the Competition, no person shall, without the prior authorisation by the Professional Advisor, disclose, exhibit or publicise the submitted Entries in any form and if found it may lead to disqualification.
- 3.7.3 In order to maintain anonymity, it is the Professional Advisor who will open the envelopes containing the identification of the Participants, and these identities will not be disclosed to anyone except the Professional Advisor until announcement of the results of the Competition.

## Part Four - Competition

#### 4.1 The Organiser

The Organiser of the Competition is National Games Coordination Office (Hong Kong), Culture, Sports and Tourism Bureau under the Government of the Hong Kong Special Administrative Region of the People's Republic of China.

#### 4.2 The Co-Organiser

The Co-Organiser is The Hong Kong Institute of Architects.

#### 4.3 The Organising Committee

The Organising Committee is composed of the members and supported by the staff as listed in **Annex 6**.

#### 4.4 The Professional Advisor

- 4.4.1 The Organiser has appointed Registered Architect (R.A.) Corrin Chan Chui Yi as the Professional Advisor of this Competition. All correspondence related to this Competition shall be addressed to the Professional Advisor via email: NGDesignCompetition@hkia.net.
- 4.4.2 The Professional Advisor shall have the absolute right and discretion to (a) determine the eligibility of any Participant and (b) interpret and apply the terms contained in this Competition Document.
- 4.4.3 The Professional Advisor's decision as mentioned above in clause 4.4.2 shall be final, binding and conclusive. The Professional Advisor shall not be obliged to disclose any information concerning his deliberations or decisions.

#### 4.5 The Jury Panel

- 4.5.1 Entries shall be adjudicated by a Jury Panel composed of the members as listed in **Annex 6**.
- 4.5.2 The Organising Committee reserves the right to change the number, composition and members of the Jury Panel without prior notice to the Participants, and such would be updated on the Competition Website.
- 4.5.3 One (1) reserve juror will be appointed for the purpose of replacing any juror who, owing to matters outside the control of the Organising Committee, is unable to perform the juror's duty at the time of adjudication of the submitted Entries.
- 4.5.4 The Organiser undertakes to accept the decisions made by the Jury Panel in relations to the selection of the Winning and Commendation Entries as final.

#### 4.6 The Technical Committee

- 4.6.1 The Jury Panel will be assisted by a Technical Committee composed of the members as listed in **Annex 6**.
- 4.6.2 The Organising Committee reserves the right to change the number, composition and members of the Technical Committee without prior notice to the Participants, and such would be updated on the Competition Website.
- 4.6.3 The main role of the Technical Committee is to pre-examine the Entries in order to assess the technical aspects of the Entries including the requirement outlined in this Competition Document.
- 4.6.4 The Technical Committee will not have any voting rights in the adjudication process, nor will it have the right to disqualify any Entry.

#### 4.7 Eligibility

- 4.7.6 In the case that a person is withdrawn from a team, any withdrawn member(s) will have to execute all necessary documentation for assignment of Intellectual Property Rights and right of ownership to the Team Leader, waiver of moral rights and renunciation of entitlement to the Prize in a form to be prescribed by the Organiser.
- 4.7.7 It should be reminded that HKIA have promulgated Code of Professional Conduct requiring Members to permit their subordinates and others they employ or superintend to enter architectural competitions with their prior knowledge on the understanding that it would not adversely affect the Member's Practice or firm". The Winner should adhere to the requirements set out in Annex 8 and Annex 9.
- 5.1.3 By registering for the Competition, Participants are deemed to have obtained consent or approval from their offices or employers for such arrangement at clause 5.1.2.

#### 5.2 Language and Time

- 5.2.1 Except otherwise specified therein, Entries, shall be in English. Participants are reminded that the explanatory statement required in this Competition Document shall be submitted in both English and Traditional Chinese.
- 5.2.2 Time mentioned in this Competition Document shall be **Hong Kong time**.

- 5.4.2 Upon submitting Entry for the Competition, the Participant (including all members of a Team Participant) declares, warrants, agrees and undertakes as set out in **Annex 4**.
- 5.4.3 The Participant (including all members of a Team Participant) shall duly execute and provide to the Government the Deed of Assignment and Undertaking **Annex 5**.

#### 5.5 Confidentiality of Entries

5.5.1 All Participants shall keep the Entries confidential and take such necessary steps to ensure the same is not disclosed to any third parties throughout the Competition until the final announcement of the results of the Competition.

#### 5.6 Remuneration

- 5.8.2 The Organiser may at its discretion cancel, modify or suspend the Competition. The Participants shall not be entitled to any compensation as a consequence to such cancellation, modification or suspension of the Competition.

#### 5.9 Jurisdiction

#### 1. Spatial Requirements

#### 1.1. Site A - Central & Western District Promenade (Central Section)


- 1.1.1. Dimension of the site for installation: approximate perimeter length of 20 m, 8.15 m, 24m, 14.5m
- 1.1.2. Any foundation of the installation is to be 300 mm away from the site boundary as stated.
- 1.1.3. Height Limit is 6m from ground level.

#### 1.2. Site B - Kai Tak Station Square

1.2.1. Dimension of the site for installation is:

Location B1: approximately  $15 \text{ m} \times 8.5 \text{ m}$ Location B2: approximately  $10 \text{ m} \times 10 \text{ m}$ 

- 1.2.2. Any foundation of the installation is to be 300 mm away from the site boundary as stated.
- 1.2.3. Height Limit is 6m from ground level.
- 1.2.4. For B1 site: there are existing 2 benches nearby. Participants can choose to relocate the benches or integrate the benches into their proposal.



1.2.5. For B2 site: the site is with Kai Tak Tunnel below, next to existing drainage reserve.

#### 2. Structural Requirements

2.2. the loading limitation for the sites are:



2.3. No structural footing deeper than 1 m below ground level is permitted.


#### 2.4. Site A

2.4.1 The site is resting on the existing underground tunnel structure and its diaphragm wall.

Footing above diaphragm wall shall not be deeper than +5.0 mPD. No part of the footing shall encroach into 5m clear zone above the structure of the tunnel. Please refer to the extent of the tunnel and its diaphragm wall as below:



2.4.2 The site is not a flat surface, but with a gentle gradient. Please refer to the as-built site plan as below:



### 2.5. <u>Site B1</u>

- 2.5.1 The site is next to an existing Drainage Reserve. No structures are permitted to be on the Drainage Reserve.
- 2.5.2 Footing and loading design need to comply with Drainage Services Department's requirements.

#### 2.6. Site B2

The site is resting on top of existing Kai Tak Tunnel. Installation at B2 needs to be of light weight similar to street furniture scale, with minor footing structure. The structural calculation and design are subject to Highways Department's approval.

- 2.7. As the structures are permanent installations, wind load shall be assessed in accordance with the "Code of Practice on Wind Effects in Hong Kong 2019" issued by Buildings Department.
- 2.8. Structural calculations and checking are to be submitted after the commissioning to verify that there are no implications on the existing Kai Tak Tunnel, Central-Wanchai Bypass.





# 4. Building Services

- 4.1. Please note that no electricity is to be supplied.
- 4.2. Design proposals are encouraged to use solar and or other sustainable energy source, if needed.
- 4.3. If the design proposal is to involve fixed electrical installation, a certified true copy or the original of the work completion certificate Form WR1(A) should be provided.
- 4.4. All metalworks associated with an electrical installation but not forming part of a live conductor, including exposed conductive parts and extraneous conductive parts, shall be solidly and effectively bonded and earthed in accordance with the Code of Practice for the Electricity (Wiring) Regulations.
- 4.5. The provision of a lightning protection system may be considered in accordance with ADV-6 issued by the Buildings Department.
- 4.6. The proposed design should avoid affecting existing utilities as far as possible. In case that any existing underground utilities will be affected, the winning teams and their contractors shall also be responsible for seeking approval by the maintenance department, and carry out any diversion or reinstatement works as may be needed.

# 5. Safety & Health Requirements

- 5.1. The design proposal is to uphold site safety of the public when visitors are visiting or interacting with the installations. Sharp edges and entangling possibilities to children & visitors are not permitted.
- 5.2. Materials proposed should be of low VOC and with ingredients causing no harm to human health.
- 5.3. For any assessable area over or at 600mm above, safety railing is to be provided.
- 5.4. The installation is to be barrier free, wheelchair accessible.

#### 6. Materials

- 6.1. As the installations will be permanent, materials must be selected for durability and endurance to weathering.
- 6.2. Consideration on sustainability and circulating in the choice of materials is encouraged.

#### 7. Maintenance

- 7.1. A 10-year life expectancy is required for the installation of the winning design proposals.
- 7.2. No electrical parts are to be included in the installation, unless it is self-powered.
- 7.3. A low and easy maintenance Installation is preferred.
- 7.4. For details of Technical Requirements in Maintenance Aspect, please refer Annex 9.

### 8. Sustainability & Circularity

- 8.1. Sustainable design with environmentally-friendly, recyclable materials with low carbon footprint is encouraged.
- 8.2. Design for Carbon Neutrality and Circularity is encouraged.

#### 9. General

- 9.1. The design, as well as construction procedures and safety, should comply with all relevant prevailing statutory requirements.
- 9.2. The participants are to make any necessary revisions to the design after award of the contract, in order to address comments from the relevant Government departments.
- 9.3 A plaque containing brief information about the 2025 National Games in Hong Kong, design statement of the winning proposals, and credit to the sponsor of the installation (if applicable) shall be installed at or by the side of the installation. The proposed design is required to take into account this plaque of commemoration, where the content and information on which shall be approved by the Organiser upon selection of the winning entries.

# 簡介 Introduction

四年一度的中華人民共和國運動會(全運會)由國家體育總局主辦,是國家水平最高、規模最大的全國性大型綜合運動會。第十五屆全運會(十五運會)將於2025年11月9日至21日在廣東、香港和澳門舉行,全國各地的頂尖運動員將會雲集粤港澳三地,競逐各項賽事的殊榮。 香港將會承辦八個競賽項目,包括籃球(男子22歲以下組)、場地自行車、擊劍、高爾夫球、手球(男子)、七人制橄欖球、鐵人三項及沙灘排球,以及一個群眾賽事活動項目,亦即保齡球。此外,由深圳及珠海分別舉行的田徑馬拉松及公路自行車賽事,計劃以跨境形式舉行,以展現粵港澳三地融合發展。

全國第十二屆殘疾人運動會暨第九屆特殊奧林匹克運動會(殘特奧會)由中國殘疾人聯合會與國家體育總局合辦,將於第十五屆全運會結束約兩星期後(即2025年12月8日至15日),在廣東、香港和澳門舉行,地點與第十五屆全運會相同。香港將會承辦四個競賽項目,包括殘奧項目硬地滾球、輪椅擊劍和乒乓球(IT11組),以及特奧項目乒乓球。此外,香港也會舉辦一個大眾項目輪椅舞蹈。

Organised by the General Administration of Sport of China once every four years, the 15th National Games (NG) is the country's highest-level and largest national multi-sports event. The 15th NG will be held in Guangdong, Hong Kong and Macao from 9 to 21 November 2025. Elite athletes from different provinces, municipalities and special administrative regions will gather in the three places to vie for top honours in different events. Hong Kong will stage eight competition events, namely basketball (men U22), track cycling, fencing, golf, handball (men), rugby sevens, triathlon and beach volleyball, as well as one mass participation event, which is bowling. Besides, athletics marathon and road cycling events, which will be organised by Shenzhen and Zhuhai respectively, are being planned to run through Guangdong, Hong Kong and Macao to showcase the integrated development of the three places.

The 12th National Games for Persons with Disabilities and the 9th National Special Olympic Games are co-organised by the China Disabled Persons' Federation and the General Administration of Sport of China and will be held about two weeks after the 15th National Games (i.e. from 8 to 15 December 2025). Same as the 15th National Games, these national events will be conducted in Guangdong, Hong Kong and Macao. Hong Kong will stage four competition events: boccia, wheelchair fencing and table tennis (TT11) for the NGD, and table tennis for the NSOG. In addition, Hong Kong will organise one mass participation event of para dance sport.

## 2) 會徽 Emblem

十五運會和殘特奧會的會徽以「繁榮、包容」為立意·由代表廣東省、香港及澳門三地的木棉、紫荊、蓮花花瓣交 疊旋轉形成圖案·通過提取花朵外形和色彩·環繞花心螺旋圍合一體·形成同心禮花·同時捕捉了禮花綻放的瞬間,寓意粵港澳大灣區交融互通、活力無限、背靠祖國、綻放世界。

The emblem for the 15th NG, the 12th NGD and the 9th NSOG encapsulates the themes of "prosperity and inclusiveness" and features three intertwining and rotating petals from the cotton tree, bauhinia and lotus, each representing Guangdong, Hong Kong and Macao respectively. The arrangement, inspired by the natural forms and hues of these flowers, spirals around a central core, crafting a pattern reminiscent of blooming fireworks. This artistic motif signifies not only the seamless integration and boundless vitality of the Guangdong-Hong Kong-Macao Greater Bay Area (GBA) but also its flourishing impact on the global stage, bolstered by the strong support of our country.

## 3) 吉祥物的象徵意義 Symbolic meaning of the mascots

The two mascots are adorable and have been named "Xiyangyang" and "Lerongrong", symbolising joy, harmony, reunion and beauty.

Design and Build Contract

Design and Build Contract:

The followings are the key points of the Design and Build Contract only. They do not

represent the final version, and are not exhaustive.

1. The 2 winning proposals will be adopted as the design of the construction and

installation at Site A and Site B respectively

2. The 2 winners/ winning teams will be appointed as the Commissioned Architects

and will be engaged individually into a 'Design and Build' contract for the design,

production, installation of the selected sites; The 'Design and Build' contract is to be

signed by a Registered Company in representation of winners/ winning teams. The

Registered Company is as nominated by the participant in Annex 3.

3. Upon the appointment of Commissioned Architects, the winning team is to submit the

followings in seven (7) calendar days' time for PA and OC's approval and comments:

a) proposed Implementation programme (to complete within the time frame as set)

b) proof of compliance to loading requirements

c) structural calculations

d) detailed drawings for construction

e) registered contractor capacity, documents for the design to desires fabricate and

install the winning proposal locations as designated at the Site A and B

f) to provide design detail drawings and specifications for the registered contractor(s)

to carry out the fabrication (including mock up a prototypes), and installation of the

design works.

4. The budget allowed for the 2 installations is:

Design Fee: HK\$500,000 (for each site)

Construction cost allowed:

Site A: HK\$4.5 million

Site B: HK\$5.5 million

• The design and build contract must adhere to the budget allowed. No addition cost is to

be permitted, unless as approved by PA and OC.

The fee for the team of AP, RSE and Independent Checkers within the construction cost is

to be capped under HK\$500,000.

An Auditor Report is to be provided to ensure the proper use of the public money.

5. The winning teams are to execute the works diligently with their contractor, and must complete the installation at the following time frame:

Tentative Commencement of work: June 2025

Completion of work: Mid-October 2025

Deflect Liability Period : 1 year upon Practical Completion

- The actual timing is subject to final confirmation by the Government.
- No claim for extra cost is allowed, should the commencement or completion of work is rescheduled or caused by the contractor's own delay.
- 6. The Commissioned Architects are to report to the Government on a bi-weekly basis; attend to valuing and site meetings.
- 7. For the design and build contract, the Commissioned Architects are responsible for the fabrication and installation of the commissioned works.
- 8. For commissioned works that involves accessibility of people, the proposal needs to be in line with the Design Manual Barrier Free Access 2008 (2024 Edition).
- 9. Hoarding shall be provided at the perimeter(s) of the work area(s) during the course of construction and adequate precautions be carried out to ensure public safety during the course of fabrication and installation.
- 10. Arrangement of hoarding and safety precautions shall be submitted to relevant Government departments for comment / approval prior to the commencement of works.
- 11. Adequate access around the Project area for the general public shall be maintained.
- 12. During the course of fabrication and installation, all possible disturbance and nuisance to other users shall be kept to the minimum.
- 13. The Commissioned Architects are to provide Registered Structural Engineer (RSE) and Authorized Person (AP) and Independent Checkers (IC) listed in relevant registers published by the Buildings Department; in compliance to the Building Ordinance (Cap 123) and other statutory compliance, Fire Services and Fire Escape requirements.
- 14. The Commissioned Architects are responsible to make submissions and obtain approval from the relevant Government authorities as applicable in relation to the works. This may also involve submissions to maintenance parties of the underground structures / utilities in the

proximity of the architectural installations, future maintenance parties of the proposed architectural installations, and/or authorities for structural alteration (if any), provision of barrier-free access facilities, provision office safety facilities or other statutory provisions. As the sites A and B2 are with close proximity to existing underground tunnels, i.e. Central-Wanchai By-pass and Kai Tak Tunnel, the proposal shall be submitted to the Highways Department for approval prior to commencement of construction works.

- 15. The Commissioned Architects are to conduct site visits with PA/PM Team and representative of the Government and to familiarize with the existing conditions of the designated locations.
- 16. To submit contractor's fabrication, fabrication construction details, shop drawings for AP/RSE's comments and approval. AP/RSE shall take up the whole design responsibilities of the works. AP/RSE shall submit the design calculations and drawings of the architectural installations to the Independent Checkers for checking. AP/RSE shall also check contractor's design, construction method statement, shop drawings and construction materials etc., complying with the relevant Code of Practice and statutory requirements.
- 17. Provision of qualified and designated site staff to monitor and supervise the production and installation of the commissioned Works to ensure the site safety and environmental issues/ provisions are in full compliance with relevant site safety and environmental legislation, to compile records of all non-conformities found on site and rectification actions taken for regular submission on monthly basis to the PA and Architectural Installation Manager.
- 18. Periodically inspect the site works and ensure that the completed works are upon the satisfactory of the Architectural Installation Manager and PA. The respective site inspection record shall be submitted to the PA and Architectural Installation Manager for consideration within seven (7) days from the date of inspection.
- 19. Independent checker shall check and certify that all design calculations and drawings (including revisions to the calculations, revision to drawings, shop drawings and builder's work drawings), construction method statement, temporary works and construction materials etc., are in compliance with the relevant Code of Practice, design requirements as stated in this competition documents and statutory requirements, and are properly and safely designed. Independent Checker's checking certificate shall be appended in each of the AP/RSE/contractor's submission for user departments' record.

- 20. To compile a suitable defects list for follow up rectification by the Works Contractors upon completion of works within fourteen (14) calendar days from the date of inspection.
- 21. To make any necessary revisions to the design after the award of the contract, in order to address comments from relevant Government departments and to ensure all relevant prior approval/ acceptance from the respective authorities are obtained in advance prior to the commencement of site works.
- 22. During the progress of works, attendance to ad hoc project meeting convened by PA /
  Architectural Installation Manager with relevant parties for resolution of any special concerns
  or on-site difficulties.
- 23. Diligently and successfully complete the Project in accordance with the agreed programme of works, the contract requirements, schedule, budget and any relevant requirements as confirmed by the Government.
- 24. To assign and provide a designated and qualified Project Coordinator to coordinate and liaise the site works arrangements in full compliance with the requirements of the Project.
- 25. Ensure all site works; site safety and environmental issues being carried out in accordance with the contractual requirements.
- 26. Provide appropriate quality of workmanship in accordance with Architectural Services Department's "General Specification for Building 2022 Edition" (<a href="https://www.archsd.gov.hk/media/publications-publicity/general-specification-for-building/GS\_2022-01.pdf">https://www.archsd.gov.hk/media/publications-publicity/general-specification-for-building/GS\_2022-01.pdf</a>) and "General Specification for Building Services Installation in Government Buildings of The Hong Kong Special Administrative Region 2022 Edition" (Incorporating Corrigendum No.GSBS03-2022) (<a href="https://www.archsd.gov.hk/media/publications-publicity/general-specification-for-building-serivces/BSGS%202022%20Edition\_wCorr%20GSBS03-2022%20%28Oct24%29.pdf">https://www.archsd.gov.hk/media/publications-publicity/general-specification-for-building-serivces/BSGS%202022%20Edition\_wCorr%20GSBS03-2022%20%28Oct24%29.pdf</a>).
- 27. The Commissioned Architects are to produce and submit (all duly signed by AP and/or RSE) working drawings within fifteen (15) calendar days from the final approval of the Architectural Installation Works proposal as specified in Clause 11(c) below, including but not limited to:
  - i. Detailed Layout Plan of the Works at the designated location in Site A and B;
  - ii. Detailed design drawings for the Al Works with elevation, sections, and construction details, etc. (in 1 to 20 scale and/or larger);

- iii. Material Schedules for the works;
- iv. Color illustrations, perspective views; and
- v. Material sample boards.
- 28. Certification of the structural safety of the architectural installation and compliance with the relevant statutory requirements for the materials and works shall be duly signed by RSE and Independent Checker. The certificates shall be submitted to the user departments for record before completion of the works.
- 29. The execution of the Building Services Installations shall conform to all statutory enactments, Ordinances, subsidiary legislations made under the Ordinances, Code of Practices, Practice Notes, Technical Memorandum, Circulars, Guidance Notes, guidelines, manuals, specifications and procedures issued by the Government of the HKSAR. Relevant international standards, guidelines and rules of utility companies shall also be complied as appropriate.
- 30. Submit meeting notes/ records for project meetings and correspondence with concerned parties within seven (7) calendar days from date of request/ confirmation by Architectural Installation Manager.
- 31. The Commissioned Architects are to commence site works in accordance with the Works Programme as specified in the Design-and-build Works Contract.
- 32. To complete of all fabrication works for Project in accordance with the Works Programme as requested/specified in the Design-and-build Works Contract.
- 33. The Commissioned Architects are to engage qualified site safety officer(s) to ensure the site safety and environmental issues/ provisions in full compliance with relevant Government site safety and environmental legislation, if required.
- 34. Notify the PA and Architectural Installation Manager promptly of any site accident/ mishaps or events of public concern as soon as practicable.
- 35. Arrange pre-handover inspection at least one (1) week, and formal handover of the designated MI Works to the Government at least three (3) working days, before the scheduled installation completion date.
- 36. Notwithstanding anything to the contrary in the "Design & Build" the Contract Documents, the Government reserves the right to disqualify and terminate the contractual relationship with

Commissioned Architects or any parties on the grounds that the party has engaged, is engaging, or is reasonably believed to have engaged or be engaging in acts or activities that are likely to caused or constitutes the occurrence of offences endangering National Security or otherwise the exclusion is necessary in the interest of national security, or is necessary to protect the public interest of Hong Kong, public morals or public safety.

- 37. Under the Spirit of item 33, The Government Representative shall be entitled to forthwith terminate this Contract but without prejudice to any other rights which the Government Representative has or may if.
- 38. Preliminaries shall be allowed by the winners / winning teams for provision of safety measures, temporary water and power supplies. (Prior agreement of LCSD on provision of temporary water and power supplies to the winners / winning teams for the installation work with or without cost shall be sought).
- 39. Should the winners refuse to carry out the work after result announcement, or due to ill-performance of the Commissioned Architects, the organizer has the right to select the other winning entries to carry out the works.

Technical Requirements in Maintenance Aspects

Since the selected designs will be installed permanently, maintenance factors are a significant consideration. The Commissioned Architects must adhere to the following technical specifications:
